I am looking forward to our year end meeting - and because we were successful in reaching out to our Oakton scholarship winner, she will be attending. She received \$1000 this year from our branch. Even costs at community colleges have been rising steadily – especially in cash strapped Illinois. The money for the Oakton scholarship, and the money we give to AAUW National each year (\$500 this year), comes from our branch reserves - funds built up over time

**YOU HAVE A VOICE IN AAUW!**

Those of us who have been AAUW members for many years remember that voting on national issues and officers was done by delegates at convention, but that is no longer the case. Each AAUW member is now entitled to vote directly, either electronically or by paper ballot (request) on issues and for those who will serve on the National board. The recent issue of *Outlook* that you received includes the information on changes in the Public Policy Program, proposed amendments to Bylaws, proposed resolutions, and the bios of all those seeking board positions.

Most of the changes are straightforward and reasonable. The one that will engender controversy is the proposal to eliminate the requirement of a degree for membership.

Our president, Cindy Grau, sent the following:

At our branch board meeting I mentioned that AAUW Elections are open right now and will continue through the end of the National Convention, June 15 at 8pm CST. Each member in AAUW is eligible to vote and encouraged to do so. However, it may be tough to know for whom to vote, it takes time to research each director and there are 10 director positions to vote for. I asked a friend of mine who serves on the national fundraising committee for recommendations as she is familiar with many of the candidates.

If you want to vote online at our May 11 meeting, I can bring an iPad and we can pass it around. To vote, please have your AAUW *Outlook* magazine available as your unique member number and voter ID number printed on your magazine are required to vote. AAUW will mail you a paper ballot if you request it before May 4<sup>th</sup>.

Our Public Policy Chair, Lisa Crocco, has sent information about *The Peoples Climate March* that will take place on Saturday, April 29, sponsored by the League of Women Voters. Meeting place will be the corner of Clark and Adams in Chicago at 11:15 a.m., then moving to Federal Plaza where the main event will take place. This is one of the events scheduled across the country to speak out about the dismantling of environmental oversight and protection at the federal level.

## **IT'S DUES TIME!**

Because AAUW's fiscal year ends on June 30, we are collecting dues money NOW. Our dues remain the same as they have been for several years, \$71.00, broken down as follows: \$49.00 for National, \$10.00 for State, \$12.00 for local. Paid National Life members pay only state and local dues, a total of \$22.00. Honorary Life Members, those who have been members of AAUW for fifty years or more, do not need to pay any dues at all. Of the dues paid to National, \$46.00 is deductible as a charitable contribution, if you itemize for your federal income tax; the remaining part of the national dues goes for lobbying, which is not deductible. State and local dues cannot be deducted.

(If you don't know your membership number, you can obtain it there or you can find it on the back cover of the AAUW *Outlook*.) It's quick and it's easy!

Of course, your treasurer will certainly be happy to take your dues and process them. A form is found on the next page. Please help by paying, one way or another, promptly so that your treasurer does not need to hound you!
