Kris Salyards, LCSW, Executive Director of The Harbour, will be the speaker at our next branch meeting on Saturday, November 10th at the Des Plaines Public Library. This agency provides comprehensive housing and case management for girls and young women between the ages of twelve and twenty who are homeless and is helping to fill a great need. This is the agency for which we provided backpacks before school started this year, and we know that they were very much appreciated. Now we have the opportunity to hear more about the program and how it is administered.

A FOLLOW-UP ON OUR CANDIDATES' FORUM

Some controversy has followed the Candidates' Forum that we co-sponsored with the League of Women Voters of Park Ridge. The Illinois Opportunity Project, which is running Marilyn Smolenski's campaign, filmed the event with the understanding that the footage would be shared with the sponsoring organizations and not be used for political purposes.

The video was never shared with us and in the last few days emails were sent out by the campaign with video clips of the event, as well as mailers, TV commercials, and Facebook posts. (The TV commercials were put out by Liberty Principals PAC, which is not legally allowed to coordinate with the candidate's campaign committee. The IOP denies sharing the video with them.)

The letter written by the president of the Park Ridge League of Women Voters follows. It was published in the *Daily Herald* and the *Journal*. The state LWV was involved, as well. It looks like the PAC used the video in the TV commercial, which would be a violation of campaign finance law. Mary Moylan's campaign has consulted a lawyer based on the agreement signed by both candidates. It did not specify that there would be no recordings; the agreement about recordings was verbal. Cindy

The League of Women Voters of Park Ridge recently hosted a candidate forum for the Illinois 55th House District, between candidates Marty Moylan and Marilyn Smolenski.

All candidates who agree to participate in League forums are made aware that the League does not support of oppose any candidate or political party.

Both campaigns asked to videotape the event with the verbal agreement that the video could be used for internal purposes only.

Additionally, Marilyn Smolenski's campaign (managed by the Illinois Opportunity Project) offered to share its video with us to post for community members who could not attend.

Unfortunately, the League never received the video despite numerous attempts to contact the campaign.

Even worse, footage from the forum has since been used in an attack ad against Marty Moylan that was shared via email to Smolenski's mailing list.

We are profoundly disappointed that the Smolenski campaign chose not to follow our ground rules that state explicitly, "No voice, image or other duplication of the forum may be used by any candidate's representative or campaign in any campaign advertising."

In the spirit of civility and good faith, we ask that the Smolenski campaign remove the League forum footage from its ad immediately.
