Once again we are approaching the end of our fiscal year and so it is time for us to have our annual meeting. Holly Sorensen was hired at the Des Plaines Library as Head of Adult Services in 1999 and served in that position until September, 2007, when she was promoted to Assistant Director. She became Executive Director in 2010 and will retire from the library at the end of June of this year. As the Executive Director, she led the \$2.5 million renovation of the building from 2015 to 2018, completing the project on time, within budget, and without raising the tax levy!

Our AAUW branch has benefited greatly from the Des Plaines Public Library. For several years the Library has partnered with us to present expensive speakers in a large enough venue for the community to attend – for example, Leslie Goddard who portrayed Eleanor Roosevelt in March. They have also made meeting rooms available to us as a branch and as an executive committee; our Work Smart seminar in April was held at the library with registration through the library's website.

We are pleased to be able to honor Holly Sorensen in this way and look forward to having her with us at our annual meeting dinner.

AAUW NEWS FROM WASHINGTON

Paycheck Fairness Act Passes in House of Representatives

On March 27, the House of Representatives voted 242-187 to pass the Paycheck Fairness Act with bipartisan support. Since the start of the 116th Congress, AAUW has been working to ensure swift passage of this critical pay equity legislation without any weakening amendments. AAUW staff worked with Congressional offices and seeveral letters to the Hill, as well as organizing coalition letters with hundreds of signers. AAUW CEO Kim Churches published an op-ed on the importance of the bill. And AAUW also submitted a statement for the bill's hearing record in the House Education and Labor Committee. Additionally, AAUW advocates sent over 3,000 emails and made more than. AAUW 400 calls to House offices in support of the Paycheck Fairness Act. By passing this important bill, members of the House of Representatives who supported the bill have demonstrated their commitment to the economic security of American women and their families. The bill now moves to the Senate, and AAUW urges senators to act now to pass the Paycheck Fairness Act.

All People Should Have Equal Rights

America's civil rights laws should reflect that promise by protecting everyone. Yet despite significant progress, discrimination remains a persistent problem for LGBTQ Americans. That's why it's critical that Congress pass the Equality Act, which would amend existing federal civil rights laws to provide explicit protection against discrimination based on sexual orientation and gender identity in a number of key areas. The Equality Act would update our civil rights laws to provide important new protections against sex discrimination, including on the basis of sexual orientation and gender identity.

AAUW opposes all forms of discrimination and supports the civil rights of all individuals. Our nation's civil rights laws must be updated to protect *all* of us — no one should experience unfair treatment because of their gender identity or sexual orientation.

Take action today to urge your members of Congress to ensure protections against discrimination by supporting the Equality Act.

IT'S TIME TO RENEW YOUR MEMBERSHIP

Annual memberships expire on June 30 of each year, so it is now time to renew. There is no change in dues for this year, but the branch will be submitting dues electronically to national and state. Because we had trouble receiving local dues that were paid directly to AAUW by several members last year, we are asking that this year you pay your dues to the branch by check and then they will be submitted to national and state. The total amount is: \$59 for national (\$56.00 of this is deductible for tax purposes); \$10.00 for state; \$12.00 for local = \$81.00. If you are a paid national life member, the amount is \$22.00; honorary life members do not have to pay any dues, but contributions to the branch are appreciated.
