<u>Maria Tallchief</u>: Elizabeth Marie "Betty" Tallchief was an American ballerina. She was considered America's first major prima ballerina. She was the first Native American to hold the rank and is said to have revolutionized ballet. Almost from birth, Tallchief was involved in dance, starting formal lessons at age three. She was born on January 24, 1925 in Fairfax, OK and died on April 11, 2013 in Chicago.

#### **NEWS FROM STATE AND NATIONAL**

State Convention - As you may expect, it will be virtual this year. We plan to follow tradition and hold the meeting beginning on Friday afternoon and resuming on Saturday. You will be receiving more information, but we are looking at mid to late April weekend dates.

Greatest Needs Fund - As the calendar year winds down, branches and individual members are considering donations to funds. #### **ERA Advocates Focus on Senate and First 100 Days**

At the start of 2020, Virginia became the final state to ratify the Equal Rights Amendment. The resolution went to the National Archivist for certification. This ministerial task is proscribed by federal statute and this process was followed by Nevada, Illinois, the archivist and every state that ratified the "Madison Amendment" in the 90's. This time, a lawsuit prevented that from happening.

Although the original lawsuit, brought by Alabama, South Dakota and Louisiana, was voluntarily dismissed in March, legal wrangling continues with two parallel lawsuits against the Archivist – one brought by private parties and the other between states.

Meanwhile, the US House of Representatives voted on February 13 to remove the time limit for ratifying the amendment. The resolution is now before the Senate as S.J.Res. 6. There is a small window of opportunity during the lame duck session.

At this point, there are three possible outcomes:

- The Senate votes to remove the time limit, and the Supreme Court defers to Congress using the political question doctrine.
- The Supreme Court directs the Archivist to certify ratification without Congressional action. The ERA would then become part of the U.S. Constitution.
- The Supreme Court decision dismisses the ERA, and advocates must restart the ratification process.

While the composition of the Senate is uncertain, who chairs the Judiciary committee and who serves as the senate majority leader exercises near complete control of what matters come for a vote. The upcoming Georgia runoff elections are of great interest to equality advocates who believe there are already the requisite votes to remove the deadline. The roadblock has been getting a senate vote.
