

# 2023 GUN SAFETY REPORT CARD ILLINOIS STATE LEGISLATURE





#### **DEAR SUPPORTER.**

The Gun Violence Prevention Action Committee (GVPAction) is proud to release its third annual Gun Safety Report Card for 2023. The legislation in the Gun Safety Report Card is the culmination of the work of survivors, public supporters, and gun safety champions who advocated tirelessly for laws that will keep Illinois children, families, and communities safe from gun violence.

Sadly, firearms continue to be the leading cause of death for Illinois children and across the nation. From 2018 to 2021, there was a 41.6% increase in the firearm death rate for U.S. children and teens. In 2021, among children who died by firearms, 84.8% were male, 49.9% were Black, and 82.6% were aged 15 to 19 years. Gun violence is ripping children from their parents, loved ones from their families, and neighbors from our communities. We cannot allow ourselves to be desensitized to this violence. It leaves a wake of trauma across our communities that takes decades or more to recover. Gun violence is a public health epidemic and we must continue to advocate for measures to end it in Illinois.

This year, we saw two life saving measures signed into law. On January 10, 2023, Illinois became the 9th state to pass comprehensive legislation banning the sale and possession of assault weapons (Protect Illinois Communities Act). The law imposes an immediate ban on the manufacturing and sale of assault weapons, high-capacity magazines, and switches in Illinois. It extends the duration of a Firearm Restraining Order (FRO) from 6 months to one year and gives states attorneys standing to assist in filing a FRO. The law enacted Universal Background Checks for private gun sales starting July 1, 2023, and created an anti-gun trafficking strike force at Illinois State Police.

In May, 2023, Illinois passed the Firearms Industry Responsibility Act (FIRA), a law that allows victims and survivors of gun violence to hold gun manufacturers accountable through legal action for the harm they have caused by either their actions or inactions. FIRA makes clear that the Illinois Attorney General's office can use Illinois' Consumer Fraud and Deceptive Business Practices Act to take enforcement action against firearms dealers and manufacturers that engage in dangerous sales and marketing practices. The law prohibits advertising and marketing that encourages para-military or unlawful private militia activity and prevents advertising to minors that encourages the use of a firearm in a manner not authorized by law, including advertising that uses cartoons, stuffed animals and clothing targeted towards children. FIRA levels the playing field and treats gun manufacturers like any other industry in America, which can face legal action if they break the law.

Despite the progress we have made, our work is far from over. After the actions by the United States Supreme Court this year striking down evidence-based gun safety laws, we must continue to pass legislation to address this public health crisis at the state level. We look forward to advancing evidence-based policies that reduce illegal guns, gun trafficking, straw purchasing, require safe gun storage and remove guns from domestic abusers.

Please know that we cannot do our work without the support of people like you. Gun violence affects everyone in our state, and we are committed to achieving an Illinois free of gun violence. Holding our officials accountable is a critical element of this progress to a more peaceful Illinois and it is my hope that you will find this helpful in understanding which of your officials are committed to creating safe communities for everyone.

Thank you for your commitment to ending gun violence in Illinois.

#### Members of the 103rd General Assembly

#### **HB 5471\* Protect Illinois Communities Act (PICA)**

Bans the sale and possession of assault weapons, imposes an immediate ban on the manufacturing and sale of assault weapons, high-capacity magazines, and switches.

#### **HB 218 Firearms Industry Responsibility Act (FIRA)**

Allows victims and survivors of gun violence to hold gun manufacturers accountable through legal action for the harm they have caused by either their actions or inactions.
